Duration of Hire

The term of the hire shall commence and cease at the time and dates described within the hire agreement. The hirer remains liable for additional rental charges if the vehicle is not returned by the specified time and date.

Payment by Hirer

The hirer shall pay to the owner the full amounts indicated in the agreement for the hire of the vehicle and any such additional charges as indicated in the hire agreement. In the event of an accident or theft the hirer will be liable to pay the cost for repairs or replacement costs of the vehicle.

Hirers Obligations

The hirer shall ensure that all reasonable care is taken in handling and parking the vehicle and that the vehicle is left securely locked when not in use.

The cost of fuel used during the term of the hire is the responsibility of the hirer. The vehicle is delivered fully fueled and has to be returned fully fueled. If not refueled on return PURE Krabi will charge 100 THB per (partial) divider bar on the fuel meter.

The hirer is encouraged to take pictures of any existing damage to the vehicle before hire commences.

Indemnity Exclusions

The indemnities referred to above shall not apply where damage, injury or loss arises when –

- The driver of the vehicle is under the influence of alcohol or any drug that affects his ability to drive the vehicle
- The vehicle is in an unsafe or un-roadworthy condition that arose during the course of the hire and that caused or contributed to the damage or loss, and that the hirer or driver was aware of or ought to be aware of the unsafe or un-roadworthy condition of the vehicle.
- The vehicle is operated in any race, speed test, rally or contest.
- The hirer is not a body corporate and the vehicle is driven by any person not-named as being authorized to drive the vehicle as listed in the hire agreement.
- The vehicle is driven by any person who at the time when he drives the vehicle is disqualified from holding, or who has never held, a license appropriate for that vehicle or who is not insured by additional insurance.

Mechanical Repairs

If the vehicle is damaged or requires repair or salvage, whether because of an accident or breakdown, the hirer shall advise the owner of the full circumstances by telephone as soon as practicable. The hirer shall not arrange or undertake any repairs or salvage without the authority of the owner except to the extent that the repairs or salvage are necessary to prevent further damage to the vehicle or other property.

The hirer shall ensure that no person shall interfere with the distance recorder or speedometer, or, except in an emergency, any part of the engine, transmission, braking, or suspension systems of the vehicle.

Use of Vehicle

The hirer shall not use or permit the vehicle to be used for the carriage of passengers for hire or reward.

The hirer shall not –

- Sublet or hire the vehicle to any other person
- Permit the vehicle to be operated outside his authority
- Operate the vehicle, or permit it to be operated in circumstances that constitute an offence by the driver, which relates to driving or attempting to drive with excess breath or blood alcohol or under the influence of drink or drugs.
- Operate the vehicle or permit it to be operated in any race, speed test, rally or contest
- Operate the vehicle or permit it to be operated to tow any other vehicle
- Operate the vehicle or permit it to be operated for the transport of more than the number of passengers, or more weight of goods specified in the certificate of loading for the vehicle
- Drive or permit the vehicle to be driven by any person who is not a holder of a current driver's license appropriate for the Vehicle

In the event of an accident

You are obliged to inform the police and the rental company immediately and provide a police report. Please phone us immediately if you are unfortunate enough to have an accident of any kind.

Return of Vehicle

The hirer shall, at or before the expiry of the term of the hire, in person, return the vehicle to a PURE Krabi representative, not to the hotel or agent, or obtain the owners consent to the continuation of the hire. Whenever possible all vehicles are hired out in a clean condition, therefore it is the responsibility of the person hiring the vehicle to return it in the same condition and fully refueled.

Immediate Vehicle Return Where Damage or Default

The owner shall have the right to terminate the hiring and take immediate possession of the vehicle if the hirer fails to comply with any of the terms of the hire agreement, or if the vehicle is damaged. In case of an accident where the vehicle is repossessed, the remaining rental fee is NOT refunded. The termination of the hiring shall be without prejudice to the rights of the owner and the rights of the hirer under the hire agreement.

Disputes not covered by this agreement

If any dispute arises, for which there is no solution covered by this agreement, the dispute will be dealt with according to Thai local laws.

Drivers License

All drivers must hold a current, non-probationary license. The license may either be Thai, or from a renter's country of residence (with an English translation), and an additional international drivers permit. Licenses must be carried at all times when driving. Having a proper license is the full responsibility of the renter.

- **You will be covered for bail bond with a maximum of ฿500,000**
- **Maximum insured amount of persons on the bike is 2**
- **There is no limit on the amount of drivers**
- **You will need additional personal medical insurance to be covered for medical care. This is not included in this policy.**
